8. TO RECEIVE AND DISCUSS MATTERS RAISED BY MEMBERS AND CHESHIRE EAST MEMBER

- J **Speeding Traffic** – Cllr. Wray reported that a meeting had been organised by Cllr. Moran of Sandbach Town Ward in response to concerns raised by a number of residents of Bradwall Road in Sandbach. Cllrs Moran and Wray were in attendance along with the local PCSO, Highways Officers from Cheshire East Council and members of the public. It was agreed that the Clerk should contact Cllr. Moran and request that Bradwall Parish Council be included in any future meetings.
- J **Livestock Market** – Cllr. Wray updated members on a potential proposal to open a livestock market on the A5022, Holmes Chapel Road, Sandbach. This is the site currently being used by the M6 widening contractor, Kier Group plc. Kier are due to move off the site in July 2019 and it is believed a planning application will be submitted after this occurs.
