a) Footpath at Smithy bends

The Cheshire East officer dealing with this has revised the design to remove the "gateway" structure and has indicated that there would be no installation cost because Willis Brothers have agreed to complete the work free of charge. It was resolved to request that Cheshire East go ahead with ordering the signs and poles as soon as possible.

Despite repeated requests for remedial work or a date for such work to take place the Highways department have not responded. The Clerk will contact the Ward Councillor to request his involvement in this matter.
